
In pursuing new innovation goals SCVS ECORK Division is glad to introduce you a new family of absorbent products, according the latest UE and national standards.


In the heart of SCVS R&D sector there are the Circular Economy Guidelines, aimed at closing down the waste cycle and at the maximum recovery of second raw materials.

The new line contains from 35% to 100% recycled material from waste processing and the use of **Puroilsorb** production allows significant savings in energy and lower production of Greenhouse Gas (CO<sub>2</sub>).



### **PUROILSORB "CUSCINI"**

Polyurethane based absorbent pads for the recovery of oils and hydrocarbons poured into the sea, lakes, rivers and other surface waters. Pads are crafted in various sizes and are suitable for use in the sea according to Italian Ministry of the Environment.

Polyurethane absorbing barriers for the absorption of oily substances and hydrocarbons spilled into sea, lakes, rivers and other surface waters.
